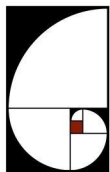

2. Transportation Agreement: *Guardians, please read and initial each point below to acknowledge.*

_____ I, the undersigned guardian of the student club participant, understand that Thomas MacLaren School does NOT provide transportation for club practices, competitions, etc. and that it is the guardians' responsibility to set up and provide transportation and carpooling for their children. I can email the Clubs Coordinator to ask for help arranging a carpool.

_____ In the event that my child is transported by a School employee (Faculty or Staff) or Club Leader for any reason, then I, on behalf of myself and my child, hereby release and waive any claim of liability against Thomas MacLaren School and its officers, directors, leaders, teachers, employees, agents, and volunteers (together, "Released Parties") with respect to any damage, loss, illness, injury, or death related to or arising out of my child's participation in Extracurricular activities.

3. Pickup Policy: *Guardians, please read and initial each point below to acknowledge.*

_____ Club leaders will escort their student participants outside to the pickup lane after club meetings. Students will be supervised outside for only 10 minutes after the scheduled end of their club meeting; any student who has not been picked up in that time will be escorted back inside the lobby to continue waiting with the Clubs Coordinator. **For most Upper School clubs, students will leave the building at 4:35 and wait outside until 4:45.** I understand that pickups after this time (or more than 10 minutes after the end of the club meeting) will require me to park and enter the lobby to sign my child out.

_____ Furthermore, I understand that I will be charged for childcare at a rate of \$1/minute if I do not pick up my child within 15 minutes of the scheduled end of their club meeting. **For most Upper School clubs, charges of \$1/minute will begin to accrue at 4:50 p.m.** In case of emergency, please call the school to discuss other arrangements. Repeated late pickups will lead to a warning, and if the issue is not resolved then my child may be removed from the club without a refund.

4. Guardian Consent: *Guardians, please read and sign below to acknowledge.*

I understand that participation in extracurricular activities includes an inherent risk of injury, which may range in severity from minor to long-term catastrophic. I understand that serious injuries are not common in supervised school programs, but that it is impossible to eliminate the risk.

Participants can help reduce their chance of injury by obeying all safety rules and reporting any/all physical problems to their club leader. Participants have a responsibility to help reduce their chances of injury in these ways, and I have discussed this expectation and those given in the Student Activities Handbook with my student club participant.

I also agree to indemnify and hold harmless the Released Parties with respect to any claim asserted by or on behalf of me or my child as a result of damage, loss, illness, injury, or death related to or arising out of my child's participation in activities. I understand that this waiver and release applies to all claims, including claims arising out of the negligence of released parties, but does not apply to claims of criminal conduct, intentional or reckless tortious acts, or gross negligence.
